AN ORDINANCE ADOPTING AN ACT TO REGULATE THE STORAGE, TRANSPORTATION, SALE AND USE OF GASOLINE AND VOLATILE OILS. APPROVED JUNE 28, 1919., RULES AND REGULATIONS RELATING TO GENERAL STORAGE, RULES AND REGULATIONS RELATING TO SERVICE STATIONS and GASOLINE AND VOLATILE OILS, GENERAL RULES.

WHEREAS, the following Law, rules and regulations relating to the storage, transport, sale and use of gasoline and volatile oils, and the Law prescribing the color and lable for gasoline or benzol receptacles has been published in pamphlet form by the State of Illinois Department of Law Enforcement (as revised August 15, 1971) An Act to regulate the storage, transportation, sale and use of gasoline and volatile oils. Approved June 28, 1919., Rules and Regulations Relating To General Storage, Rules and Regulations Relating To Service Stations, Gasoline and Volatile Oils, General Rules, and

WHEREAS, three copies of such pamphlets have been on file with the City Clerk of Urbana, Illinois, for at least fifteen (15) days immediately preceding the adoption of this Ordinance in accordance with Section 1002 of Chapter 85, Illinois Revised Statutes, 1971,

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF URBANA, ILLINOIS, that:

Section 1. The following Law, rules and regulations relating to the storage, transportation, sale and use of gasoline and volatile oils and the Law prescribing the color and label for gasoline or benzol oil, as such are set forth in the pamphlet entitled, "Gasoline and Volatile Oils", which said pamphlet is on file with the City Clerk of the City of Urbana, Illinois, is hereby adopted and made part of the ordinances of the City of Urbana.

Section 2. Any person who shall violate this Ordinance shall be subject to the penalties set out in Section 1.6 of the Urbana City Code.

Section 3. This Ordinance shall be in full force and effect from and after its passage and publication in accordance with the terms of Section 1 - 2 - 4 of the Illinois Municipal Code.
