

AN ORDINANCE AMENDING THE URBANA CATV FRANCHISE ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF URBANA, ILLINOIS,

that:

Section 1. In Section 7 (2) the words "continually keep on file with the City" are hereby repealed and in their place shall be inserted the words "file with the City by February 1st and August 1st each year".

Section 2. In Section 7 (6) the word "the" immediately preceding the word "franchise" is hereby repealed and in its place shall be inserted the word "a".

Section 3. In Section 10 (10) the words "will extend" are hereby repealed and in their place shall be inserted the words "hereby extends".


Section 4. In Section 21 (2) wherever the number "twenty (20)" appears, such is hereby repealed and in its place shall be inserted the number "thirty (30)".

Section 5. In Section 26 (1) between the words "Grantee" and "violates", insert the word "knowingly".


This Ordinance shall be in full force and effect from and after its passage and publication in accordance with the terms of Section 1 - 2 - 4 of the Illinois Municipal Code.



Section 4. In Section 21 (2) wherever

is hereby repealed and in its place  
shall be inserted the number "thirty  
(30)".

Section 5. In Section 20 (1) between  
the words "commences and violates",  
insert the words "knowingly".
