Section 2. In Section 7, the Subsection entitled "Materials & Supplies" shall be amended to read as follows:


Building Paint	\$ 450.00



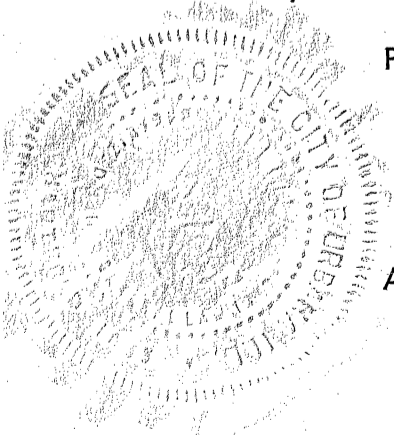
