commonly known as 601 McArthur Drive, Urbana, Illinois.


Section 2. The conditional use permit hereby granted is subject to the following conditions and limitations:

2. That the number of children involved in the conditional use permit would not exceed four (4).


This Ordinance shall be in full force and effect from and after its passage and publication in accordance with the terms of Section 1 - 2 - 4 of the Illinois Municipal Code.
