

ORDINANCE ANNEXING CERTAIN TERRITORY  
TO THE CITY OF URBANA

WHEREAS, the hereinafter described territory is situated in unincorporated territory adjacent to and contiguous to the City of Urbana, Illinois, and is part of the Carroll Fire Protection District, and Notice was given to the Trustees of the said Fire Protection District, said Notice being mailed on October 1, 1973, that this Ordinance would be voted upon at the regular meeting of this Council at 7:30 P.M. Monday, October 15, 1973, and the Affidavit of mailing such notices was duly recorded with the Recorder of Deeds of Champaign County, Illinois, and

WHEREAS, a written Petition signed by all of the owners of Record and all electors residing therein, of all land within such territory, has been filed with the City Clerk of the City of Urbana, Illinois, requesting annexation thereof to the City of Urbana, and

WHEREAS, it has been determined that said Petition complies with all requirements of the law therefor, and

WHEREAS, the majority of the members of the Council are of the opinion that it would be for the best interests of the People of the City of Urbana, Illinois, that said territory be annexed to and made a part of the said City,

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS,

Section 1. That the following described real estate, viz:

The West Half (W 1/2) of the South one-third (S 1/3) of the following property taken as a tract: Lots six (6) to eleven (11), both inclusive of a subdivision of the West Half (W 1/2) of the Northwest Quarter (NW 1/4) of Section Nine (9), Township Nineteen (19) North, Range Nine (9) East of the Third Principal Meridian, in Champaign County, Illinois,

together with a street right-of-way legally described as follows:

The full street right-of-way of Kerr Avenue, a right-of-way of width fifty (50) feet, from the corporate limits of the City of Urbana which lie along the East Line of the right-of-way of Boyden Avenue, thence East 495 feet along the South Line of the West Half (W 1/2) of the South One-third (S 1/3) of the following property taken as a tract: Lots six (6) to eleven (11), both inclusive, of a subdivision of the West Half (W 1/2)

of the Northwest Quarter (NW 1/4) of Section Nine (9), Township Nineteen (19) North, Range Nine (9) East of the Third Principal Meridian, in Champaign County, Illinois, to the West Line, extended, of the same property, all situated in Champaign County, Illinois,

commonly known as 802, 804, 806, 808, 810, 812, 814, 816, 818, 820, 822 and 824 Kerr Avenue, Urbana, Illinois,

be and the same is hereby annexed to the City of Urbana, Illinois.

Section 2. That the City Clerk be authorized and directed to file for record a certified copy of this Ordinance together with an accurate map of the territory hereinabove described in the Office of the Recorder of Deeds for Champaign County, Illinois.

Section 3. This Ordinance shall be in full force and effect from after its passage and recording as provided by law.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council on the 15<sup>th</sup> day of October, A.D. 1973.




Section 3. This Ordinance shall be in full force and effect from after its passage and recording as provided by law.

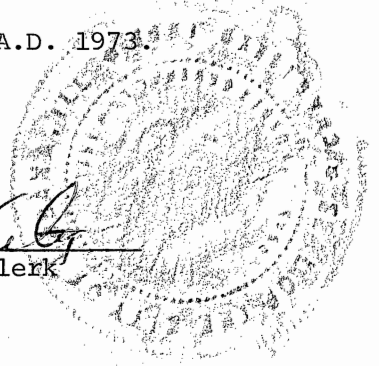
