

ORDINANCE ANNEXING CERTAIN TERRITORY
TO THE CITY OF URBANA

WHEREAS, the hereinafter described territory is situated in unincorporated territory adjacent to and contiguous to the City of Urbana, Illinois, and is part of the Carroll Fire Protection District, and Notice was given to the Trustees of the said Fire Protection District, said Notice being mailed on November 13, 1973, that this Ordinance would be voted upon at the regular meeting of this Council at 7:30 P.M., Monday, December 3, 1973, and the Affidavit of mailing such notices was duly recorded with the Recorder of Deeds of Champaign County, Illinois, and

WHEREAS, a written Petition signed by all of the owners of Record and there being no electors residing therein of all land within such territory, has been filed with the City Clerk of the City of Urbana, Illinois, requesting annexation thereof to the City of Urbana, and

WHEREAS, it has been determined that said Petition complies with all requirements of the law therefor, and

WHEREAS, the majority of the members of the Council are of the opinion that it would be for the best interests of the People of the City of Urbana, Illinois, that said territory be annexed to and made a part of the said City,

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS,

Section 1. That the following described real estate, viz:

Lots 15 and 16 in Wm. T. Webber Estate in the West Half of the Northwest Quarter of Section 9, Township 19 North, Range 9 East of the Third Principal Meridian, Champaign County, Illinois, sold by T. R. Webber, Administrator, and Lot 14 of said Estate except the West 180.50 feet of the North 432.00 feet known as Greenwood Cemetery all in Champaign County, Illinois, said tract containing 13.45 acres more or less, this being park district property, no electors reside thereon,

together with a street right-of-way legally described as follows:

The full street right-of-way of Kerr Avenue, a right-of-way of width fifty (50) feet, from the corporate limits of the City of Urbana which lie along a line 495 feet East of the East right-of-way line of Boyden Avenue, thence East along the North line of Lots 15 and 16 of Wm. T. Webber Estate in the West half of the Northwest Quarter of Section 9, Township 19 North, Range 9 East of the Third P.M., Champaign County, Illinois, to the East line of said Lot 16,

commonly known as 1001 E. Kerr Avenue, Urbana, Illinois,

be and the same is hereby annexed to the City of Urbana, Illinois.

Section 2. That the City Clerk be authorized and directed to file for record a certified copy of this Ordinance together with an accurate map of the territory hereinabove described in the Office of the Recorder of Deeds for Champaign County, Illinois.

Section 3. This Ordinance shall be in full force and effect from after its passage and recording as provided by law.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council on the 3rd day of December A.D. 1973.





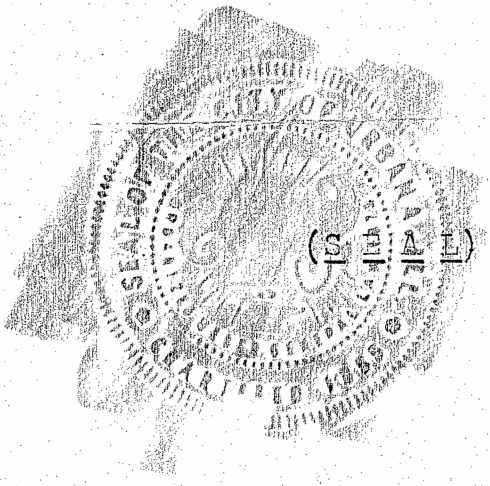
