

## AN ORDINANCE AMENDING ORDINANCE NUMBER 7273-82, ANNUAL SALARY ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF URBANA, ILLINOIS, that Ordinance No. 7273-82 is herewith and hereby amended in the following respects:

Section 1. In Section 1 thereof, "Administrative Assistant to the Mayor ... \$9,803.00" is hereby repealed and in its place is enacted the following: "Administrative Officer ... \$14,500.00".

Section 2. In Section I thereof, repeal "\$2,000.00" and enact "0.00", as pertains to Chief Examiner.

Section 3. In Section II thereof, in the Finance Department part thereof, the figure \$7,144.00 is repealed and the figure \$8,200.00 is enacted as relates to the Administrative Secretary.

Section 4. In Section II thereof in the Mayor's Office part thereof, the figure \$7,144.00 is repealed and the figure \$8,200.00 is enacted as relates to the Administrative Secretary.

Section 5. In Section II thereof, in the Public Works Department part thereof, "Code Enforcement Administrator ... \$11,309.00" is hereby repealed and in its place is enacted the following: "Administrator, Code Enforcement Department ... \$14,000.00".

Section 6. Except for the salary figures related to positions and offices exempted from Civil Service regulations, all maximum salary figures as set forth in the said Ordinance are hereby repealed.

Section 7. From the effective date of this Ordinance, minimum and maximum salaries for each employee subject to Civil Service regulations shall be as set forth in the attached table, which is incorporated herein and made a part of this Ordinance, in conformance with the designation by the Urbana Civil Service Commission of the proper level pertaining to each position.

Section 8. The Mayor is hereby authorized and directed to establish for each employee and appropriate range step that such employee shall be in within the level designated by the Urbana Civil Service Commission, provided, however, that in no event shall the salary of any employee be reduced below its present level thereby.

This Ordinance shall be effective February 1, 1974.
