

ORDINANCE NO. 7374-71

AN ORDINANCE AMENDING CHAPTER 33A, "UTILITY TAX" OF THE URBANA CITY CODE OF 1968

BE IT ORDAINED BY THE CITY COUNCIL OF URBANA, ILLINOIS, that:

1. The figure "3%" as is set forth in Section 33A.1. of the Urbana City Code of 1968, in subsections (a), (b), (c) and (d) thereof, is herewith repealed upon the effective date of this Amendatory Ordinance.

2. In place of the "3%" figure herein repealed shall be inserted, and is hereby enacted, the figure "4%".


3. As amended herein, the entire Chapter 33A "Utility Tax" of the Urbana City Code of 1968 is herewith readopted.

This Ordinance shall be effective as of and from this date.



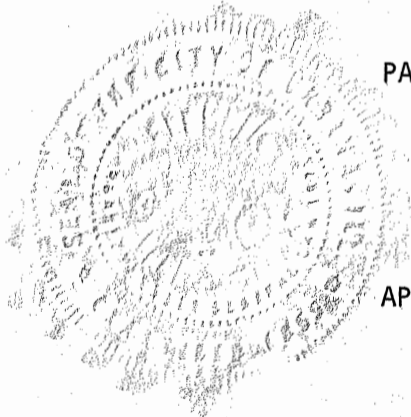
