

ORDINANCE ANNEXING CERTAIN TERRITORY
TO THE CITY OF URBANA

WHEREAS, the hereinafter described territory is situated in unincorporated territory adjacent to and contiguous to the City of Urbana, Illinois, and is part of the Carroll Fire Protection District, and Notice was given to the Trustees of the said Fire Protection District, said Notice being mailed on May 16, 1974, that this Ordinance would be voted upon at the regular meeting of this Council at 7:30 P.M., Monday, June 17, 1974, and the Affidavit of mailing such notices was duly recorded with the Recorder of Deeds of Champaign County, Illinois, and

WHEREAS, a written Petition signed by all of the owners of Record and all electors residing therein of all land within such territory has been filed with the City Clerk of the City of Urbana, Illinois, requesting annexation thereof to the City of Urbana, and

WHEREAS, it has been determined that said Petition complies with all requirements of the law therefor, and

WHEREAS, the majority of the Members of the Council are of the opinion that it would be for the best interests of the People of the City of Urbana, Illinois, that said territory be annexed to and made a part of the said City,

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS,

Section 1. That the following described real estate, viz:

A part of Lot 2 of a Subdivision of the West Half of the Northwest Quarter of said Section 9, Township 19 North, Range 9 East of the Third Principal Meridian, described as follows: Beginning at the Northeast corner of said Lot 2 and running thence West 184' to the point of beginning, thence West 80', thence South 165', thence East 80' thence North 165' to the point of beginning, situated in Champaign County, Illinois,

commonly known as 901 Bradley Avenue, Urbana, Illinois, and also

That part of the full foot right-of-way of Perkins Road from a point 184 feet West of the Northeast corner of Lot 2 of a Subdivision of the West Half of the Northwest Quarter of Section 9, Township 19 North, Range 9 East of the Third Principal Meridian, thence 80 feet West,

be and the same is hereby annexed to the City of Urbana, Illinois.

Section 2. That the City Clerk be authorized and directed to file for record a certified copy of this Ordinance together with an accurate map of the territory hereinabove described in the Office of the Recorder of Deeds for Champaign County, Illinois.

Section 3. This Ordinance shall be in full force and effect from after its passage and recording as provided by law.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called of a majority of the Members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council on the 17th day of June, A.D. 1974.
