

AN ORDINANCE AMENDING THE URBANA LOCAL TRAFFIC ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF URBANA, ILLINOIS, that:

Section 1. Parking shall be prohibited at all times on both sides of Florida Avenue between Philo Road and James Cherry Drive.

Section 2. Parking shall be prohibited on the north side of Hill Street from Busey Avenue to Lincoln Avenue.

Section 3. Parking shall be prohibited on the south side of California Street from Birch Street to Cedar Street.

Section 4. Schedule IX of the Urbana Local Traffic Ordinance is hereby amended to reflect the amendments contained herein.

This Ordinance shall be effective ten days after its passage and publication as provided by law.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called of a majority of the Members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council on the 5<sup>TH</sup> day of August, 1974.

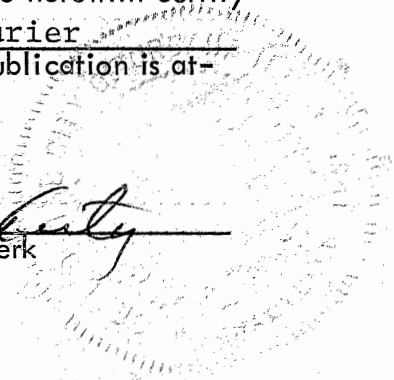
