

AN ORDINANCE ANNEXING CERTAIN LANDS

WHEREAS, a Resolution duly adopted by the Board of Education of Urbana School District 116 has been forwarded to the Corporate Authorities of the City of Urbana, Illinois, which said Resolution recommends annexation of the following described parcel to the City of Urbana, Illinois, and

WHEREAS, a Petition for annexation of the following described parcel has been filed with the City Clerk of Urbana, Illinois, requesting annexation of the following described parcel which said Petition is duly signed by the President and Secretary of the County Board of School Districts of Champaign County, Illinois, and the Urbana Park District in Champaign County, Illinois, by its President and Secretary pursuant to Resolution duly adopted by the Board of the Urbana Park District in Champaign County, Illinois, and

WHEREAS, the said Urbana Park District in Champaign County, Illinois, a body politic and corporate, is the legal owner of a portion of the following described parcel, and the County Board of School Districts of Champaign County, Illinois, is the legal owner of the remainder of the following described parcel, and

WHEREAS, no electors reside on the following described parcels, and

WHEREAS, the following described property does not lie within any fire protection district, and

WHEREAS, the following described property is presently contiguous, uninhabited and unincorporated, and

WHEREAS, it is determined by the Corporate Authorities that it is in the best interests of the City of Urbana to annex such territory to the City of Urbana, Illinois.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS,

Section 1. That the following described real estate, viz:

Tracts 1, 2 and 3 of McCullough's Plat of survey of the Northeast Quarter (NE 1/4) of Section Twenty-Nine (29), Township Nineteen (19) North, Range Nine (9) East of the Third Principal Meridian, Champaign County, Illinois, as shown on the plat recorded in the Recorder's Office of Champaign County, Illinois, as Document No. 71-R-13121 in Book "X" of Plats at Page 38,

be and the same is hereby annexed to the City of Urbana, Illinois, together with the following described street right-of-way:

That portion of a dedicated street right-of-way, commonly known as Windsor Road, having a width of one hundred (100) feet, which is bounded on the east by the existing city limits thence running westerly nine hundred twenty (920) feet to the extension of the easternmost line of Tract Seven (7) of the aforementioned survey of the NE Quarter (NE 1/4) of Section Twenty-Nine (29), Township Nineteen (19) North, Range Nine (9) East, and also: That portion of a dedicated street right-of-way, commonly known as Race Street, having a width of sixty-six (66) feet, which is bounded on the north by the extension of the north line of Tract Three (3) of aforementioned survey and bounded on the south by the southernmost line of Tract Two (2) of aforementioned survey extended.

Section 2. That the City Clerk be authorized and directed to file for record a certified copy of this Ordinance together with an accurate map of the territory hereinabove described in the Office of the Recorder of Deeds for Champaign County, Illinois.

Section 3. This Ordinance shall be in full force and effect from after its passage and recording as provided by law.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called of a majority of the Members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council on the 4 day of November, A. D. 1974.

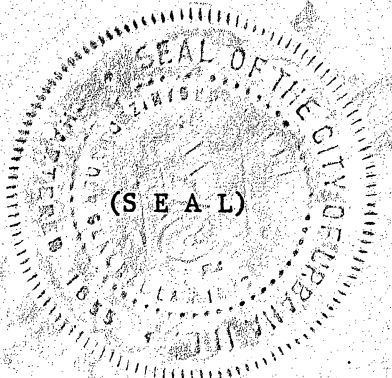
