

AN ORDINANCE AMENDING ORDINANCE NO. 7475-83

WHEREAS, on the 7th day of April, 1975, the City Council passed an Ordinance annexing Lots 1-27 in University Downs Tenth Subdivision together with all street right-of-way located within the platted subdivision, and

WHEREAS, a portion of Vine Street lies immediately adjacent to and adjoining such area, and

WHEREAS, State law requires that the boundary of any area annexed shall extend to the far side of any adjacent highway, and

WHEREAS, the said portion of Vine Street adjacent to University Downs Tenth Subdivision was inadvertently omitted from Ordinance No. 7475-83 annexing the said area.

THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF URBANA, ILLINOIS that:

Section 1. Ordinance No. 7475-83 is hereby amended to include the following described street right-of-way:

That part of the 80' street right-of-way known as Vine Street which is Southeast of the present City Limits (coincident with the South boundary of Ennis Ridge Tenth Subdivision), and Northwest of the South line of University Downs Tenth Subdivision, extended.

Section 2. That the above described street right-of-way is hereby annexed to the City of Urbana, Illinois.

Section 3. That the City Clerk be authorized and directed to file for record a certified copy of this Ordinance together with an accurate map of the territory hereinabove described in the Office of the Recorder of Deeds for Champaign County, Illinois.

Section 4. This Ordinance shall be in full force and effect from and after its passage and recording as provided by law.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called of a majority of the Members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council on the 23d day of June, 1975.






