WHEREAS, three (3) copies of the Urbana City Code of 1968, as revised and updated to date of passage of this Ordinance have been on file with the City Clerk for at least thirty (30) days prior to the adoption of this Ordinance, and

WHEREAS, Chapter 24, Section 1 - 3 - 2 permits the adoption by reference of the provisions of any public record, and

WHEREAS, Section 1 - 3 - 1 of Subsection c of Chapter 24 defines a public record as including the Ordinances of the City itself, and

WHEREAS, over and beyond any statutory power granted under Chapter 24 of the Illinois Revised Statutes, the City of Urbana, in exercise of its Home Rule powers, herewith desires to readopt the entire City Code of 1968 of the City of Urbana as revised and updated to the date of this Ordinance, including the adoption of all regulations and public records previously or attempted to be adopted, and referred therein to by reference;

THEREFORE BE IT ORDAINED BY THE URBANA CITY COUNCIL, that:

Section 1. The Urbana City Code of 1968 as revised and updated to the date of this Ordinance is herewith and hereby adopted as the Urbana City Code of 1975 and the City Clerk is hereby ordered to publish such code in pamphlet form.

This Ordinance shall be in full force and effect from and after its passage and publication in accordance with the terms of Section 1 - 2 - 4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council on the 3 day of March, 1975.
