

AN ORDINANCE AMENDING THE  
URBANA LOCAL TRAFFIC ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA,  
ILLINOIS, that:

Section 1. Parking shall be prohibited on the north side  
of Pennsylvania Avenue from Race Street to Vine Street and that  
Schedule IX be modified accordingly.

Section 2. The Traffic Engineer of the City of Urbana  
is hereby authorized and directed to relocate the center line on  
Pennsylvania Avenue adjacent to and along the north side of Blair  
Park.


Section 3. The Traffic Engineer of the City of Urbana is  
hereby authorized and directed to establish a crosswalk on the east  
side of Springfield Avenue at the intersection of Springfield  
Avenue and McCullough Street.

Section 4. The Traffic Engineer of the City of Urbana  
is hereby authorized and directed to eliminate the left turn "shadow"  
lane on Green Street at the University of Illinois Physics Building  
by placing proper curbing in the appropriate area.


This Ordinance shall be in full force and effect from
