

ORDINANCE ANNEXING CERTAIN TERRITORY
TO THE CITY OF URBANA

WHEREAS, the herinafter described territory is situated in unincorporated territory adjacent to and contiguous to the City of Urbana, Illinois, and is not part of any Fire Protection District, and

WHEREAS, a written Petition signed by all of the owners of Record and all electors residing therein, of all land within such territory, has been filed with the City Clerk of the City of Urbana, Illinois, requesting annexation thereof to the City of Urbana, and

WHEREAS, it has been determined that said Petition complies with all requirements of the law therefor, and

WHEREAS, the majority of the Aldermen are of the opinion that it would be for the best interests of the People of the City of Urbana, Illinois, that said Territory be annexed to and made a part of the said City,

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS,

Section 1. That the following described real estate, viz:
Lots 867 and 868 in Ennis Ridge Eighteenth Subdivision,
situated in Champaign County, Illinois,

also known as 404 East Brookens Drive and 402 East Brookens Drive, respectively, Urbana, Illinois,

be and the same is hereby annexed to the City of Urbana, Illinois.

Section 2. That the following described real estate, viz:

That part of the 80 foot street right-of-way known as Vine Street, commencing at the South line of University Downs Tenth Subdivision extended, southerly, to the southern line of Ennis Ridge Eighteenth Subdivision; and that part of the 60 foot street right-of-way known as Brookens Drive, commencing at the west line extended of Lot 864 in Ennis Ridge Eighteenth Subdivision, westerly to the eastern right-of-way line of Vine Street; all lying within Ennis Ridge Eighteenth Subdivision, situated in Champaign County, Illinois,

be and the same is hereby annexed to the City of Urbana, Illinois.



This Ordinance is hereby passed by the affirmative vote, the "ayes"



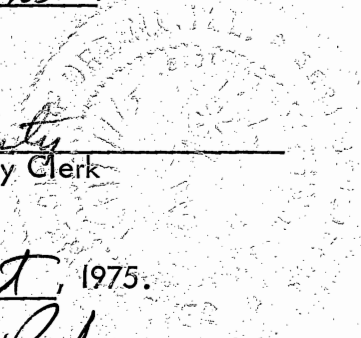

That part of the 80 foot street right-of-way known as Vine Street, commencing at the South line of University Downs Tenth Subdivision extended, southerly, to the southern line of Ennis Ridge Eighteenth Subdivision; and that part of the 60 foot street right-of-way known as Brookens Drive, commencing at the west line extended of Lot 864 in Ennis Ridge Eighteenth Subdivision, westerly to the eastern right-of-way line of Vine Street; all lying within Ennis Ridge Eighteenth Subdivision, situated in Champaign County, Illinois,

be and the same is hereby annexed to the City of Urbana, Illinois.


