

AN ORDINANCE PROHIBITING SMOKING ON BUSES

BE IT ORDAINED BY THE CITY COUNCIL OF URBANA, ILLINOIS, that from and after the effective date of this Ordinance (1) No person shall smoke or carry a lighted cigar, cigarette, pipe or match, or use any spark, flame or fire producing device on or within any vehicle used by the Champaign-Urbana Mass Transit District for public transportation, and (2) A printed notice advising the public of this Ordinance shall be posted in a conspicuous place in every vehicle used by the Champaign-Urbana Mass Transit District for public transportation.

Any person convicted of violating this Ordinance shall be fined in an amount not to exceed \$200.00.

This Ordinance shall be in full force and effect from and after its passage and publication in accordance with the terms of Section 1 - 2 - 4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called of a majority of the Members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council on the 4TH day of AUGUST, 1975.
