

ORDINANCE ANNEXING CERTAIN TERRITORY  
TO THE CITY OF URBANA

WHEREAS, the hereinafter described territory is situated in unincorporated territory adjacent to and contiguous to the City of Urbana, Illinois, and is not part of any Fire Protection District, and

WHEREAS, a written Petition signed by all of the owners of Record and all electors residing therein of all land within such territory, has been filed with the City Clerk of the City of Urbana, Illinois, requesting annexation thereof to the City of Urbana, and

WHEREAS, it has been determined that said Petition complies with all requirements of the law therefor, and

WHEREAS, the majority of the Members of the Council are of the opinion that it would be for the best interests of the People of the City of Urbana, Illinois, that said territory be annexed to and made a part of the said City,

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS,

Section 1. That the following described real estate, viz:

Lot 383 in Ennis Ridge Sixteenth Subdivision, being a part of the Northeast Quarter (NE 1/4) of the Southeast Quarter (SE 1/4) of the Southwest Quarter (SW 1/4) of Section Twenty-One (21) Township Nineteen (19) North, Range Nine (9) East of the Third Principal Meridian, situated in Champaign County, Illinois,

commonly known as 2407 Whitson Circle, Urbana, Illinois,

be and the same is hereby annexed to the City of Urbana, Illinois.

Section 2. That the following described real estate, viz:

And that part of the 60 foot street right-of-way known as Whitson Circle, commencing at the south line extended of Lot 384 in Ennis Ridge Sixteenth Subdivision, southerly to the northern right-of-way line of Scovill Street, and also that part of the 60 foot street right-of-way known as Scovill Street, commencing at the western line extended of Lot 383 in Ennis Ridge Subdivision, easterly to the eastern right-of-way line extended of Whitson Circle, all lying in Ennis Ridge Sixteenth Subdivision, situated in Champaign County, Illinois,

be and the same is hereby annexed to the City of Urbana, Illinois.

Section 3. That the City Clerk be authorized and directed to file for record a certified copy of this Ordinance together with an accurate map of the territory hereinabove described in the Office of the Recorder of Deeds for Champaign County, Illinois.

Section 4. This Ordinance shall be in full force and effect from after its passage and recording as provided by law.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called of a majority of the Members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council on the 18<sup>th</sup> day of August, A.D. 1975.

commonly known as 2407 Whitson Circle, Urbana, Illinois,

be and the same is hereby annexed to the City of Urbana, Illinois.

Section 2. That the following described real estate, viz:

And that part of the 60 foot street right-of-way known as Whitson Circle, commencing at the south line extended of Lot 384 in Ennis Ridge Sixteenth Subdivision, southerly to the northern right-of-way line of Scovill Street, and also that part of the 60 foot street right-of-way known as Scovill Street, commencing at the western line extended of Lot 383 in Ennis Ridge Subdivision, easterly to the eastern right-of-way line extended of Whitson Circle, all lying in Ennis Ridge Sixteenth Subdivision, situated in Champaign County, Illinois,


be and the same is hereby annexed to the City of Urbana, Illinois.


Section 4. This Ordinance shall be in full force and effect from after its passage and recording as provided by law.

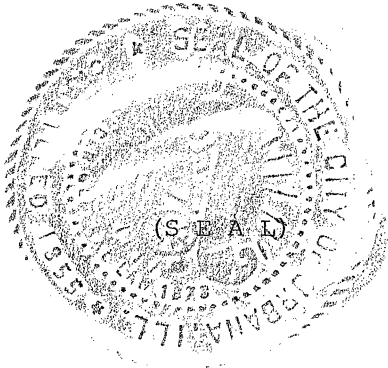
