WHEREAS, the City Council finds that those items in the list attached are no longer necessary or useful to, or for the best interests of the City of Urbana to retain:


THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, that:

Section 1. The items listed on the attached pages, which said pages are incorporated herein by reference, shall be offered for sale to the highest bidder at the next regular auction of items of personal property conducted by the City of Urbana.

Section 2. This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, passed by three-fourths (3/4) vote of the Corporate Authorities then holding office.


Section 3. This Ordinance shall be in full force and effect from and after its passage ^{and} ~~and recording~~ as provided by law.
