

ORDINANCE ANNEXING CERTAIN TERRITORY
TO THE CITY OF URBANA

WHEREAS, the hereinafter described territory is situated in unincorporated territory adjacent to and contiguous to the City of Urbana, Illinois, and is not part of any Fire Protection District, and

WHEREAS, the property described below is owned by the City of Urbana, and no electors reside thereon, and

WHEREAS, the hereinafter described territory is part of the Edge-Scott Fire Protection District, and Notice was given to the Trustees of the said Fire Protection District, said Notice being mailed on September 11, 1975, that this Ordinance would be voted upon at the regular meeting of this Council at 7:30 P.M., Monday, October 6, 1975, and the Affidavit of mailing such notices was duly recorded with the Recorder of Deeds of Champaign County, Illinois, and

WHEREAS, the majority of the Members of the Council are of the opinion that it would be for the best interests of the People of the City of Urbana, Illinois, that said territory be annexed to and made a part of the said City,

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS,

Section 1. That the following described real estate, viz:

The West Twenty (20) Rods of the South West Quarter of the North West Quarter of Section Ten (10), Township Nineteen (19) North, Range Nine (9) East of the Third Principal Meridian, being the West Ten (10) acres of Lots Five (5) and Six (6) of a Subdivision of the North West Quarter of Section Ten (10), Township Nineteen (19) North, Range Nine (9) East of the Third Principal Meridian, in Champaign County, Illinois, also A part of Lots Five (5) and Six (6) of a Subdivision of the North West Quarter of Section Ten (10), Township Nineteen (19) North, Range Nine (9) East of the Third Principal Meridian, described as follows: Commencing Twenty (20) Rods East of the Southwest Corner of Lot Five (5) aforesaid, thence East 547 feet, thence North 1091 feet, thence West 547 feet, thence South 1091 feet to the place of beginning, in Champaign County, Illinois; containing a total of approximately 23.77 acres.

commonly known as 1210 East University Avenue, Urbana, Illinois, be and the same is hereby annexed to the City of Urbana, Illinois.

Section 2. That the City Clerk be authorized and directed to file for record a certified copy of this Ordinance together with an accurate map of the territory hereinabove described in the Office of the Recorder of Deeds for Champaign County, Illinois.

Section 3. This Ordinance shall be in full force and effect from after its passage and recording as provided by law.

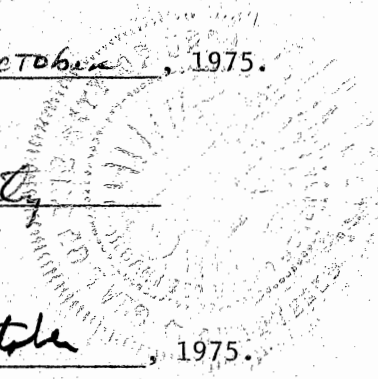

commonly known as 1210 East University Avenue, Urbana, Illinois, be and the same is hereby annexed to the City of Urbana, Illinois.

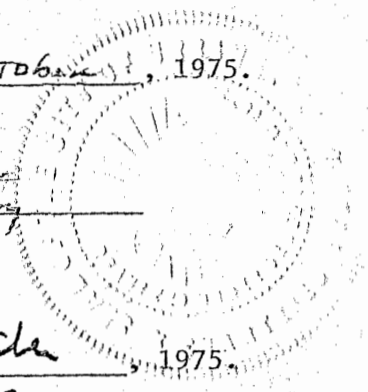

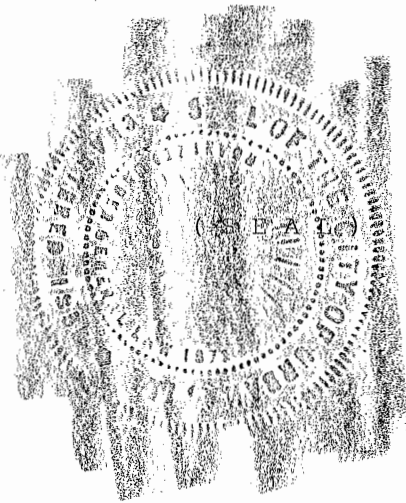
