WHEREAS, a Petition for annexation of the following described parcel has been filed with the City Clerk of Urbana, Illinois, requesting annexation of the following described parcel which said Petition is duly signed by its Vice-President pursuant to Resolution duly adopted by the Board of Commissioners of the Urbana Park District in Champaign County, Illinois, and

WHEREAS, the said Urbana Park District in Champaign County, Illinois, a body politic and Corporate, is the legal owner of a portion of the following described parcel, and

WHEREAS, no electors reside on the following described premises, and

WHEREAS, the following described property is presently contiguous, and

WHEREAS, it has been determined that said Petition complies with all requirements of the law therefor, and

WHEREAS, the majority of the members of the Council are of the opinion that it would be for the best interests of the People of the City of Urbana, Illinois, that said territory be annexed to and made a part of the said City,

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS,

Section 1. That the following described real estate, viz:

Commencing at a point 712.5 feet West of the center of Section 8-Township 19 North, Range 9 East of the 3rd P.M. and running North 0° 8' West 66.4 feet; thence West 99.4 feet; thence North 0° 8' West 265.7 feet; thence North 44° 53' East 278.5 feet; thence South 89° 55' East, 612.5 feet; thence North 0° 13' West 100 feet; thence South 82° 38' West, 617.2 feet; thence South 60° 8' East, 410.6 feet; thence East 144.4 feet to the point of beginning, containing about 1.72 acres situated in the Township of Urbana, County of Champaign and State of Illinois,

be and the same is hereby annexed to the City of Urbana, Illinois.

Section 2. That the City Clerk be authorized and directed to file for record a certified copy of this Ordinance together with an accurate map of the

territory hereinabove described in the Office of the Recorder of Deeds for Champaign County, Illinois.

Section 3. This Ordinance shall be in full force and effect from after its passage and recording as provided by law.

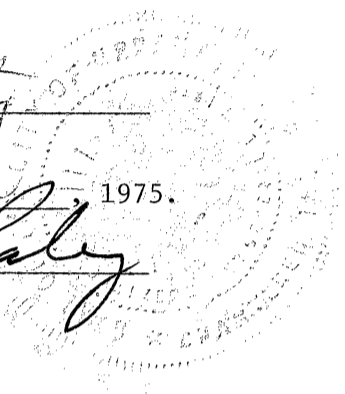



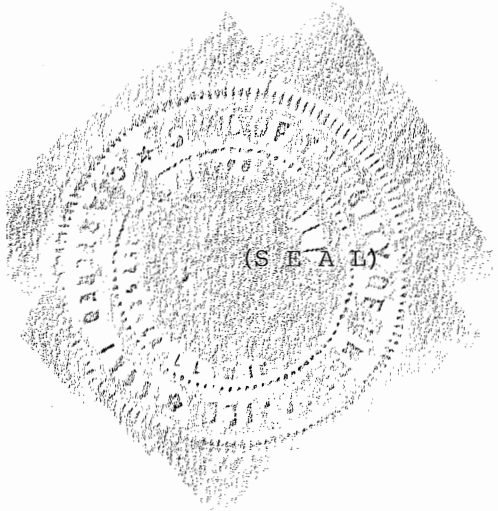
