## AN ORDINANCE AMENDING ORDINANCE NO. 7475-107, AN ORDINANCE FIXING COMPENSATION OF EMPLOYEES OF THE CITY OF URBANA, ILLINOIS

BE IT ORDAINED BY THE CITY COUNCIL OF URBANA, ILLINOIS:

That the Ordinance Fixing Compensation of Employees of the City of Urbana, Illinois, which was passed by the City Council of Urbana, Illinois, on the 30th day of June, 1975, and approved by the Mayor of Urbana, Illinois, on July 1, 1975, be amended as follows:

Section I. That Section I thereof be amended in its entirety by substituting the following:

Beginning July 1, 1975, the base (12 month) salary (excluding longevity) for each employee subject to Civil Service Regulations but exempt from representation in a collective bargaining unit shall be as set forth in the attached table, entitled "Revised Annual Salary Index", which is hereby incorporated herein and made a part of this Ordinance. Longevity shall be considered part of an employee's maximum annual salary, as set forth in the Longevity Ordinance adopted by the City Council on April 1, 1974.

Section II. That Section II thereof be amended by substituting the following salary or hourly wages for the positions hereinafter listed:
