#### ORDINANCE NO. 7576-50

AN ORDINANCE ADOPTING UNITED STATES PUBLIC HEALTH
SERVICE FOOD SERVICE SANITATION ORDINANCE AND
THE RETAIL FOOD STORE SANITATION RULES AND REGULATIONS BY REFERENCE

WHEREAS, three (3) copies of the pamphlets containing the regulations hereinafter adopted have been filed with the Office of the City Clerk as provided by law.

NOW, THEREFORE BE IT ORDAINED BY THE URBANA CITY COUNCIL AS FOLLOWS:

Section 1. The definitions; the inspection of food service establishments; the issuance, suspension and revocation of permits to operate food service establishments; the prohibiting of the sale of adulterated or misbranded food or drink; and the enforcement of this ordinance shall be regulated in accordance with the unabridged form of the 1962 Edition of the "United States Public Health Service Food Service Sanitation Ordinance", which said ordinance is hereby adopted by reference subject to the following exceptions:

- (a) The words "Municipality of \_\_\_\_\_\_", in said unabridged form shall be understood to refer to the City of Urbana.
- (b) Subsections H.7 and H.8 shall be understood to be deleted.

Section 2. Furthermore, the above said United States
Public Health Service Food Service Sanitation Ordinance is amended
by adding the following definitions:

"Retail Food Dealer" is hereby defined as any person, firm or corporation operating a retail food establishment that keeps for sale, sells or offers for sale at retail, or is in the business of delivering to consumers any article of food, confection, meat, cooked or uncooked, condiment, drink, or commodity used or intended to be used for human consumption where the same are not served for consumption on the premises. The word "retail" is hereby defined to mean the sale in small quantities direct to the consumer.

"Wholesale Food Dealer" is hereby defined as any person, firm or corporation operating a place of business used for the preparation, manufacture, canning, bottling, or distributing, sale or keeping for sale at wholesale, of any article of food, confection, condiment, drink or commodity used or intended to be used for human consumption, or any article which is an ingredient of or which enters into the composition of any such food, confection, condiment, drink, or commodity. The term "wholesale" is hereby defined to mean the making of sales to the wholesale and retail trade, including sale by jobbers and manufacturers, and the supplying of branch or chain establishments from a central depot or store.

Section 3. The Retail Food Store Sanitation Rules and Regulations published by the Illinois Department of Public Health, division of food and drugs, which said booklet was published on August of 1968 is hereby adopted as an Ordinance of the City of Urbana.

Section 4. Upon the taking effect of this Ordinance, Section 13.1 of the Urbana City Code is hereby repealed.

Section 5. Section 13.2 of the Urbana City Code is hereby repealed upon the taking effect of this Ordinance, and in its place is enacted the following:

"No person shall operate a food service establishment as defined in the United States Public Health Service Food Service Sanitation Ordinance or operate a retail food store as defined in the Retail Food Store Sanitation Rules and Regulations of the Illinois Department of Public Health, Division of Food and Drugs, without first securing a license from the City of Urbana so to do and shall pay to the Municipal Collector the fees set out in the annex to Chapter 18."

Section 6. The existing Section 13.4 of the Urbana City Code is hereby repealed and in place thereof the following is enacted:

"Sec. 13.4. License application.

Applications for licenses required by this ordinance shall be made to the Municipal Collector on forms furnished by the Municipal Collector. Each application involving food-delivery vehicles shall recite the name and address of the owner of the vehicle, the names of the persons for whom such deliveries are made, and the nature of the goods carried. The fee for

these licenses shall be as is fixed from time to time by the Urbana City Council. Each license shall expire on the 30th day of June following the date the license is issued."

Section 7. Any person violating any of the provisions of this Ordinance shall, upon conviction thereof, be punished by a fine not to exceed Two Hundred Dollars (\$200.00). Each day that a violation occurs shall be considered a separate violation for the purposes of this Ordinance.

This Ordinance shall be in full force and effect from and after its passage and publication in accordance with the terms of Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called of a majority of the Members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council on the 15th day of December, 1975.
