

ORDINANCE NO. 7576-8

AN ORDINANCE AMENDING ORDINANCE NO. 7475-95

BE IT ORDAINED BY THE CITY COUNCIL OF URBANA, ILLINOIS, that Ordinance 7475-95 heretofore passed by the City Council and approved by the Mayor is amended in the following respects:

Section 1. The following section of the Urbana Local Traffic Ordinance is amended to read as follows:

"Section 14.13.

(a) On each street in the area bounded by (but not including) Green and Race Streets, Lincoln and Florida Avenue (hereinafter called "the area"), parking on that side of the street where parking is not prohibited at all times shall be prohibited between 3:00 A.M. and 10:00 A.M., except for those vehicles displaying a valid permit issued pursuant to subsections (b) and (c) below. The foregoing parking prohibitions of this subsection shall not be operative on Saturdays, Sundays, or City legal holidays.

(b) Special parking permits shall be issued each year for the period beginning August 15 (and ending August 14 of the following year). These permits shall be sold for one hundred dollars (\$100.00).

(c) Special parking permits shall be provided without charge to employees, staff members and auxiliary personnel of Unit 116 School District who are certified by the said School District to have a regular need to visit or work at any elementary school located in the area above defined. The special parking permits issued under this subsection shall allow the vehicle to which it is affixed to park in the said area between 7:00 A.M. and 10:00 A.M. only. The parking permits issued hereunder shall be distinctive in some manner so they may be easily distinguished from permits issued under subsection (b) above. The said Unit 116 School District shall be responsible that permits issued hereunder are returned to the City of Urbana when the need for such permit by the one to whom it is issued is no longer in existence. The permits issued hereunder shall be valid from August 15 of each year until August 14th of the year following, unless sooner ordered surrendered by the said Unit 116 School District. Special permits issued under subsection (c) shall be issued only until August 14, 1977."

This Ordinance shall be in full force and effect from and after its passage and publication in accordance with the terms of Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called of a majority of the Members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council on the 4th day of August, 1975.

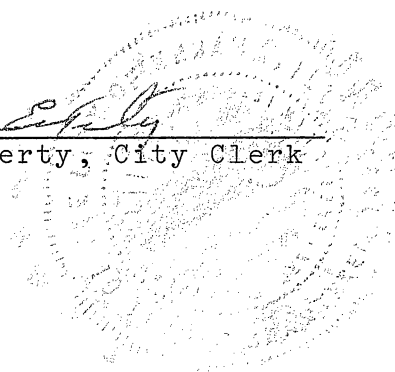
