

ORDINANCE NO. 7576-103

AN ORDINANCE AMENDING CHAPTER 12  
OF THE URBANA CITY CODE

BE IT ORDAINED BY THE CITY COUNCIL OF URBANA, ILLINOIS, that  
the following sections of the existing Chapter 12 are hereby repealed:

- Sec. 12.2. "Adoption of gas piping and applicances code."
- Sec. 12.11. "Required".
- Sec. 12.12. "Fee".
- Sec. 12.13. "Application".
- Sec. 12.14. "Information to be furnished by collector".

A new section is hereby enacted reading as follows:

"No person shall engage in any business or do any act which requires a fire prevention permit without first obtaining such permit from the City of Urbana. The fee for such permits shall be as may be fixed from time to time by the Urbana City Council."

Any person violating any of the provisions of this Ordinance shall, upon conviction thereof, be punished by a fine not to exceed Two Hundred Dollars (\$200.00). Each day that a violation occurs shall be considered a separate violation for the purposes of this Ordinance.


This Ordinance shall be in full force and effect from and after its passage and approval by the Mayor.
