

ORDINANCE ANNEXING CERTAIN TERRITORY

TO THE CITY OF URBANA

WHEREAS, the hereinafter described territory is situated in unincorporated territory adjacent to and contiguous to the City of Urbana, Illinois, and is not part of any Fire Protection District, and

WHEREAS, a written Petition signed by all of the owners of Record and all electors residing therein of all land within such territory, has been filed with the City Clerk of the City of Urbana, requesting annexation thereof to the City of Urbana, and

WHEREAS, it has been determined that said Petition complies with all requirements of the law therefor, and

WHEREAS, the majority of the Members of the Council are of the opinion that it would be for the best interests of the People of the City of Urbana, Illinois, that said territory be annexed to and made a part of the said City,

WHEREAS, since the territory herein annexed includes highways under the jurisdiction of Urbana Township and Notice was given to the Auditors of Urbana Township and the Township Commissioner of Highways, said Notice being mailed on the 19th day of December, 1975, and which said Notice stated that this Ordinance would be voted upon at the regular meeting of the City Council on the 19th day of January, 1976, and the Affidavit of mailing such Notice was duly recorded with the Recorder of Deeds of Champaign County on December 23, 1975,

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS,

Section 1. That the following described real estate, viz:

Lot 403 in Ennis Ridge Sixteenth Subdivision, Champaign County, Illinois, and also the full sixty foot width of the street right-of-way known and platted as Scovill Street, from the East line of Ennis Ridge Twelfth Subdivision to the East line of said Lot 403, extended.

commonly known as 1203 Scovill, Urbana, Illinois be and the same is hereby annexed to the City of Urbana, Illinois.

Section 2. That the City Clerk be authorized and directed to file for record a certified copy of this Ordinance together with an accurate map of the territory hereinabove described in the Office of the Recorder of Deeds for Champaign County, Illinois.

Section 3. This Ordinance shall be in full force and effect from after its passage and recording as provided by law.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called of a majority of the Members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council on the 19th day of January, A.D., 1976.



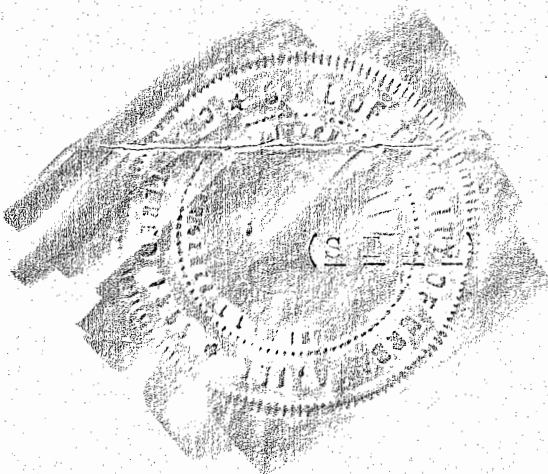
