

AN ORDINANCE AMENDING CHAPTER 16 INTOXICATING LIQUOR, SECTION 16.8 NUMBER OF LICENSES

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:

That Chapter 16, Section 16.8 of the Urbana City Code, as amended, is hereby further amended in its entirety by substituting the following:

"Not more than one Class A license shall be issued in any one year for each 1,500 population of the City. Not more than one Class AA license shall be issued in any one year for each 3,750 population of the City. Not more than one Class B, Class BB or Class BBB license shall be issued for each 1,500 population of the City. Not more than one Class C license shall be issued for each 3,750 population of the City. The population of the City for such purposes shall be determined by the latest motor fuel tax census or by the Federal census, whichever is later."

This Ordinance shall be in full force and effect from and after its passage and publication in accordance with the terms of Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called of a majority of the Members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council on the 2nd day of February, 1976.
