WHEREAS, a Petition for annexation of the following described parcel has been filed with the City Clerk of Urbana, Illinois, requesting annexation of the following described parcel which said Petition is duly signed by its Vice-President pursuant to Resolution duly adopted by the Board of Commissioners of the Urbana Park District in Champaign County, Illinois, and

WHEREAS, the said Urbana Park District in Champaign County, Illinois, a body politic and Corporate, is the legal owner of a portion of the following described parcel, and

WHEREAS, no electors reside on the following described premises, and

WHEREAS, the following described property is presently contiguous, and

WHEREAS, it has been determined that said Petition complies with all requirements of the law therefor, and

WHEREAS, the majority of the members of the Council are of the opinion that it would be for the best interests of the People of the City of Urbana, Illinois, that said territory be annexed to and made a part of the said City,

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS,

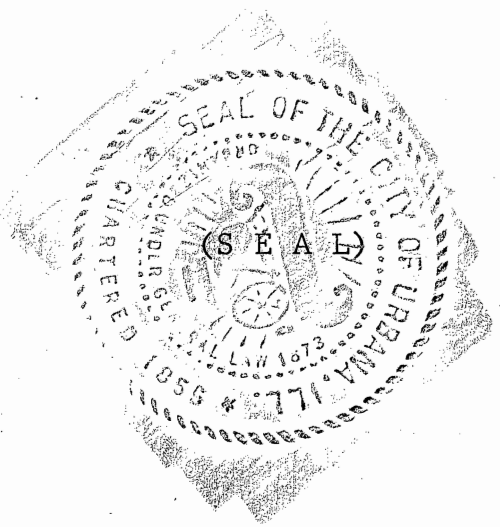
