

## ORDINANCE ANNEXING CERTAIN TERRITORY

TO THE CITY OF URBANA

WHEREAS, the hereinafter described territory is situated in unincorporated territory adjacent to and contiguous to the City of Urbana, Illinois, and is not part of any Fire Protection District, and

WHEREAS, a written Petition signed by all of the owners of Record and all electors residing therein of all land within such territory, has been filed with the City Clerk of the City of Urbana, requesting annexation thereof to the City of Urbana, and

WHEREAS, it has been determined that said Petition complies with all requirements of the law therefor, and

WHEREAS, the majority of the Members of the Council are of the opinion that it would be for the best interests of the People of the City of Urbana, Illinois, that said territory be annexed to and made a part of the said City,

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS,

Section 1. That the following described real estate,

Commencing at the Southeast Corner of the Southeast Quarter of Section 20, Township 19 North, Range 9 East of the Third Principal Meridian; thence S 89° 37' 54" W along the South line of the Southeast Quarter of said Section 20, 500.00 feet for a true place of beginning; thence S 89° 37' 54" W along the South line of the Southeast Quarter of said Section 20, 815.09 feet; thence N 00° 22' 52" W, 250.00 feet; thence S 89° 37' 08" W, 13.35 feet; thence N 00° 44' 12" W, 739.74 feet to the Southerly line of UNIVERSITY DOWNS TENTH SUBDIVISION: thence N 60° 05' 59" E along the Southerly line of UNIVERSITY DOWNS TENTH SUBDIVISION, 400.13 feet to the Westerly right-of-way line of Vine Street; thence S 39° 23' 06" E along the Westerly right-of-way line of Vine Street, 287.27 feet; thence along a curve to the right, having a radius of 1360.00 feet, said curve having a chord bearing of S 19° 54' 17" E, a chord distance of 909.65 feet, an arc distance of 927.52 feet; thence S 00° 21' 52" E, 106.28 feet, more or less to the place of beginning, said tract containing 17.85 acres, more or less, and situated in Champaign County, Illinois.

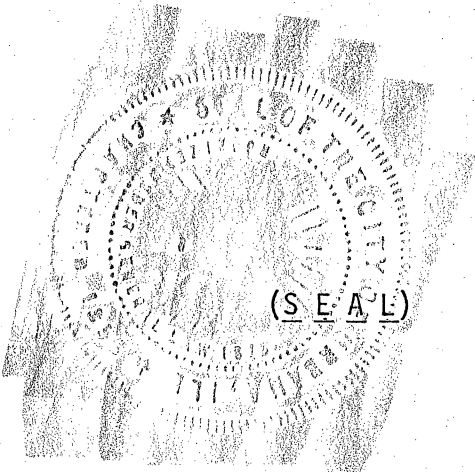
