

ORDINANCE ANNEXING CERTAIN TERRITORY  
TO THE CITY OF URBANA

WHEREAS, the hereinafter described territory is situated in unincorporated territory adjacent to and contiguous to the City of Urbana, Illinois, and is part of the Carroll Fire Protection District, and Notice was given to the Trustees of the said Fire Protection District, said Notice being mailed on July 8th, 1976, that this Ordinance would be voted upon at the regular meeting of this Council at 7:30 P.M., Monday, July 19th, 1976, and the Affidavit of mailing such notices was duly recorded with the Recorder of Deeds of Champaign County, Illinois, and

WHEREAS, a written Petition signed by all of the owners of Record and all electors residing therein, of all land within such territory, has been filed with the City Clerk of the City of Urbana, Illinois, requesting annexation thereof to the City of Urbana, and

WHEREAS, it has been determined that said Petition complies with all requirements of the law therefor, and

WHEREAS, the majority of the members of the Council are of the opinion that it would be for the best interests of the People of the City of Urbana, Illinois, that said territory be annexed to and made a part of the said City,

WHEREAS, since the territory herein annexed includes highways under the jurisdiction of Urbana Township and Notice was given to the Auditors of Urbana Township and the Township Commissioner of Highways, said Notice being mailed on the 8th day of July, 1976, and which said Notice stated that this Ordinance would be voted upon at the regular meeting of the City Council on the 19th day of July, 1976, and the Affidavit of mailing such Notice was duly recorded with the Recorder of Deeds of Champaign County on July 12, 1976.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF  
THE CITY OF URBANA, ILLINOIS,

Section 1. That the following described real estate, viz:

Commencing at the Southwest corner of the Southwest Quarter of Section 4, Township 19 North, Range 9 East of the Third Principal Meridian, Champaign County, Illinois; thence N 0° 12' 30" E along the West line of the Southwest Quarter of said Section 4, 204.19 feet for a true point of beginning; thence N 0° 12' 30" E, 182.30 feet; thence S 89° 23' 34" E, 152.89 feet; thence N 13° 34' 56" E, 160.38 feet; thence S 89° 30' 34" E, 108.00 feet; thence S 13° 34' 56" W, 65.00 feet; thence N 90° 00' 00" E, 53.07 feet; thence S 25° 20' 00" W, 159.00 feet; thence S 64° 40' 00" E, 150.00 feet; thence S 25° 20' 00" W, 70.66 feet; thence N 89° 24' 09" W, 367.82 feet to the point of beginning and that part of street Right-of-Way known and platted as Willow Road described as follows: Commencing at a point 30.00 feet East and 330.45 feet North of the Southwest corner of the Southwest Quarter of said section 4; thence N 0° 12' 30" E, 56.04 feet; thence S 89° 23' 34" E, 60.00 feet; thence S 0° 12' 30" W, 56.04 feet; thence N 89° 23' 34" W, 60.00 feet, to the point of commencement; and that part of street Right-of-Way known and platted as Cunningham Avenue described as follows: Commencing at a point 204.19 feet North of the Southwest corner of the Southwest Quarter of said Section 4 on the West line of said Southwest Quarter; thence S 89° 24' 09" E, 367.82 feet for a point of beginning; thence N 25° 20' 00" E along the existing West Right-of-Way line of Cunningham Avenue, 70.66 feet; thence S 64° 40' 00" E, 120.00 feet to the existing East Right-of-Way line of Cunningham Avenue; thence S 25° 20' 00" W, 13.86 feet; thence N 89° 24' 09" W, 132.76 feet to the point of beginning, said tracts containing a total of 2.01 acres more or less.

Section 2. That the City Clerk be authorized and directed to file for record a certified copy of this Ordinance together with an accurate map of the territory hereinabove described in the Office of the Recorder of Deeds for Champaign County, Illinois.
