

ORDINANCE NO. 7677-33

AN ORDINANCE AMENDING THE URBANA
LOCAL TRAFFIC ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Article XIV, Section 14-3, Schedule IX, of the Urbana Local Traffic Ordinance, as amended, be and the same is hereby further amended by adding to that schedule the portions of the following streets where parking shall be prohibited at all times:

| Romine | Southbound from Ellis to Church | West |

| Elm | Westbound from Cedar to Busey | North |
| Main | Westbound from Central to Goodwin | North |
| Stoughton | Westbound from Coler to Goodwin | North |
| Busey | Southbound from Springfield to Green | West |
| Coler | Southbound from Elm to Green | West |
| Gregory | Southbound from University to Springfield | West |
| Harvey | Southbound from University to Main | West |
| Mathews | Southbound from University to Main | West |
| Orchard | Southbound from Elm to Green | West |
| Vawter | Southbound from Harding to Mumford | West |

Section 2. That Article VIII, Section 8-3 of the Urbana Local Traffic Ordinance, as amended, be and the same is hereby further amended by adding to Schedule VII thereof and by repealing from Schedule VIII thereof the following intersection where drivers of vehicles shall now be required to stop before entering the intersection:

Gregory Northbound at Stoughton
Gregory Southbound at Stoughton

Section 3. That Article XIV, Section 14-4, Schedule X of the Urbana Local Traffic Ordinance, as amended, be and the same is hereby further amended by adding to that schedule the following street where parking shall be prohibited during the days Monday through Saturday:

Main Westbound from Coler to Lincoln North

and further, by repealing all portions of that schedule specifying "No Parking This Side Thursday, Friday, Saturday, and Sunday" and "No Parking Monday, Tuesday, and Wednesday".

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council on the 20th day of September, 1976.
