

ORDINANCE NO. 7677-4

AN ORDINANCE AMENDING  
THE URBANA LOCAL TRAFFIC ORDINANCE

WHEREAS, various residents around and in the vicinity of Carle Park have requested the City Council to study and take certain affirmative steps in relation to alleged traffic problems around Carle Park; and

WHEREAS, the Committee on Public Safety of the City Council has considered these suggestions and has made certain recommendations relative thereto.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF URBANA, ILLINOIS:

That Article VIII, Section 8-3, Schedule VII of the Urbana Local Traffic Ordinance, as amended, be and the same is further amended by adding to that schedule the following intersections where drivers of vehicles shall be required to stop before entering the intersection.

Carle Avenue Northbound at Indiana Avenue  
Carle Avenue Southbound at Iowa Street  
Douglas Avenue Northbound at Iowa Street  
Douglas Avenue Southbound at Indiana Avenue  
Garfield Avenue Northbound at Iowa Street  
Garfield Avenue Southbound at Indiana Avenue

This Ordinance shall be in full force and effect from and after its passage and approval by the Mayor.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of the Council on the 6th day of July, 1976.
