commonly known as 1304 South Vine Street, Urbana, Illinois.

Section 2. The conditional use permit hereby granted is subject to the following conditions:

- 1. That enrollment in the said Day Care Center at no time exceed twenty (20) children.
- 2. That the conditional use permit would be valid only as long as a valid certificate of occupancy issued by the City of Urbana is in effect.
- 3. That no less than four (4) off-street parking spaces be made available.
- 4. That the conditional use permit would be valid only as long as the State license remained in effect.
- 5. That the City of Urbana visibility triangle be complied with.
- 6. That a circle driveway be provided and that an exit be provided onto Michigan Avenue.
- 7. That the driveway and parking area be paved with an all-weather, dustless material approved by the Zoning Administrator.
