

ORDINANCE ANNEXING CERTAIN TERRITORY
TO THE CITY OF URBANA

WHEREAS, the hereinafter described territory is situated in unincorporated territory adjacent to and contiguous to the City of Urbana, Illinois, and is part of the Carroll Fire Protection District, and Notice was given to the Trustees of the said Fire Protection District, said Notice being mailed on the 29th day of April, 1977, that this Ordinance would be voted upon at the regular meeting of this Council at 7:30 P.M., Monday, May 16, 1977, and the Affidavit of mailing such notices was duly recorded with the Recorder of Deeds of Champaign County, Illinois, and

WHEREAS, a written Petition signed by all of the owners of Record and all electors residing therein, of all land within such territory, has been filed with the City Clerk of the City of Urbana, Illinois, requesting annexation thereof to the City of Urbana, and

WHEREAS, it has been determined that said Petition complies with all requirements of the law therefor, and

WHEREAS, the majority of the members of the Council are of the opinion that it would be for the best interests of the People of the City of Urbana, Illinois, that said territory be annexed to and made a part of the said City,

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS,

Section 1. That the following described real estate, viz:

A part of Lot 2 of a Subdivision of the West Half (W 1/2) of the Northwest Quarter (NW 1/4) of said Section 9, Township 19 North, Range 9 East of the Third Principal Meridian, described as follows: Beginning at the Northeast corner of said Lot 2 and running thence West 184 feet, thence South 165 feet, thence East 184 feet to the East line of said Lot 2, thence North 165 feet on the East line of said Lot 2 to the place of beginning, containing 0.69 acres more or less, all situated in Champaign County, Illinois,

commonly known as 809 East Perkins Road, Urbana, Illinois,

be and the same is hereby annexed to the City of Urbana, Illinois.

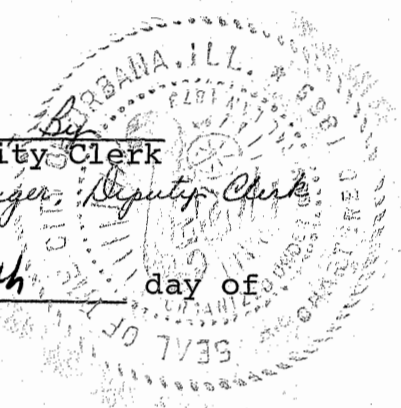

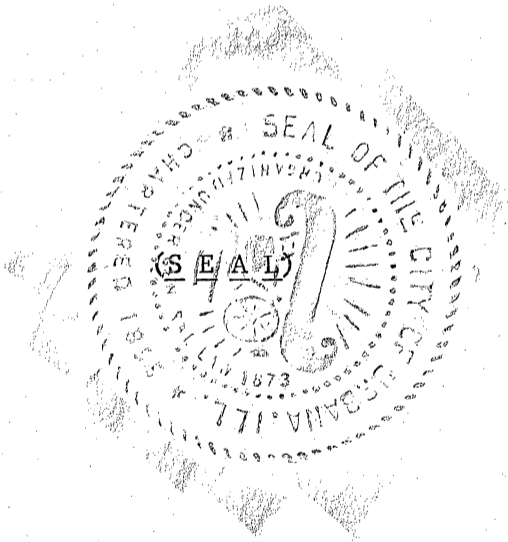
