

ORDINANCE ANNEXING CERTAIN TERRITORY
TO THE CITY OF URBANA

WHEREAS, the hereinafter described territory is situated in unincorporated territory adjacent to and contiguous to the City of Urbana, Illinois, and is part of the Edge-Scott Fire Protection District, and Notice was given to the Trustees of the said Fire Protection District, said Notice being mailed on the 24th day of March, 1977, that this Ordinance would be voted upon at the regular meeting of this Council at 7:30 P.M., Monday, April 4, 1977, and the Affidavit of mailing such notices was duly recorded with the Recorder of Deeds of Champaign County, Illinois, and

WHEREAS, a written Petition signed by all of the owners of Record and all electors residing therein, of all land within such territory, has been filed with the City Clerk of the City of Urbana, Illinois, requesting annexation thereof to the City of Urbana, and

WHEREAS, it has been determined that said Petition complies with all requirements of the law therefor, and

WHEREAS, the majority of the members of the Council are of the opinion that it would be for the best interests of the People of the City of Urbana, Illinois, that said territory be annexed to and made a part of the said City,

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS,

Section 1. That the following described real estate, viz:

A tract of land situated in the Southeast Quarter of Section 16, Township 19 North, Range 9 East of the Third Principal Meridian, Champaign County, Illinois, the boundary of which is described as follows: Beginning at the Northwest corner of Lot 1001 of the First Plat Country Squire Estates proceed Northerly along the East right-of-way of Rainbow View Drive to the South right-of-way line of Washington Street, thence Easterly along said South right-of-way line to the West right-of-way line of Kinch Street; thence Southerly along said West right-of-way line to the Northeast corner of Lot 1079 of the Fourth Plat of Country Squire Estates; thence Westerly along the North line of the Fourth Plat of Country Squire Estates and the North line of the First Plat of Country Squire

Estates to the point of beginning, and also all adjoining street right-of-way of Washington Street described as follows: Commencing at a point 40.00 feet South and 40.00 feet West of the Northeast corner of said Southeast Quarter for a true point of beginning; thence West along the South right-of-way line of Washington Street; 851.50 feet to the East right-of-way line of Rainbow View Drive; thence North, 40.00 feet to the North line of said Southeast Quarter; thence East along said North line, 851.50 feet; thence South, 40.00 feet to the point of beginning, said tracts containing 2.74 acres, more or less, all situated in the Southeast Quarter of Section 16, Township 19 North, Range 9 East of the Third Principal Meridian, Champaign County, Illinois,

be and the same is hereby annexed to the City of Urbana, Illinois.

Section 2. That the City Clerk be authorized and directed to file for record a certified copy of this Ordinance together with an accurate map of the territory hereinabove described in the Office of the Recorder of Deeds for Champaign County, Illinois.

Section 3. This Ordinance shall be in full force and effect from after its passage and recording as provided by law.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council on the 4th day of April, A.D., 1977.
