ORDINANCE NO. 7778-10

AN ORDINANCE AMENDING THE ANNUAL BUDGET ORDINANCE AND REPEALING CERTAIN OTHER ORDINANCES AND RESOLUTIONS HERETOFORE FIXING COMPENSATION FOR MANAGEMENT AND PROFESSIONAL EMPLOYEES

WHEREAS, the budget for the fiscal year commencing July 1, 1977, and ending June 30, 1978, has been duly adopted according to law and ordinance, and

WHEREAS, it is necessary to amend said budget to provide for expenditure of certain budgeted funds for the specific purposes hereinafter set forth, and

WHEREAS, funds are available for such purposes, and

WHEREAS, the amendments set forth herein are not such revisions as can be made by the Budget Director under Section 6 of the said Ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That the annual budget ordinance for the fiscal year 1977-1978 heretofore adopted by this Council be and the same is hereby amended as follows:

FROM: General Fund

Additional \$18,591.00

FOR: Salary Increases - Administrative, Professional and Supervisory Personnel

Section 2. That Ordinance No. 7374-63A, entitled "An Ordinance Amending A Certain Ordinance Entitled 'An Ordinance In Regard to Length of Service And Regulations And Compensation of Municipal Employees'", together with all prior Longevity Pay Ordinances and any amendments thereto, be and the same are hereby repealed.

Section 3. That Ordinance No. 7475-107, entitled "An Ordinance Fixing Compensation of Employees of The City of Urbana, Illinois", together with all prior ordinances annually establishing wages and benefits for those management and professional positions included on the attached list, be and the same are hereby repealed.

Section 4. That Resolution No. 7677-R7, entitled "A Resolution Amending the Minimum Benefits Program for City Employees Exempted from Collective Bargaining Units Established by Resolution No. 7576-R51A" be and the same is hereby repealed.

That the provisions entitled, "Longevity Pay", and "Pay Differential Between Ranks", of the Management Benefits Package, as established and approved by Resolution No. 7576-R51A, entitled "A Resolution Establishing Minimum Benefit Programs For City Employees Exempted from Collective Bargaining Units", be and the same are hereby repealed.

Section 6. That this Amending Ordinance shall be effective immediately upon passage and approval, and shall not be published.

Section 7. That this Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called of a majority of the City Council of the City of Urbana, Illinois, at a regular meeting of said Council held on the 18^{th} day of 9th, 1977.
