

ORDINANCE NO. 7778-27

AN ORDINANCE AMENDING THE
URBANA LOCAL TRAFFIC ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA,
ILLINOIS, as follows:

Section 1. That Schedule VII, of Section 8-3, of
Article VIII of the Urbana Local Traffic Ordinance, as amended,
be and the same is hereby further amended by adding to that
Schedule the following additional intersections where drivers
of vehicles shall be required to stop before entering the
intersection:

Vine	Northbound at George Huff
Vine	Southbound at George Huff
Vine	Northbound at McHenry
Vine	Southbound at McHenry
George Huff	Eastbound at Vine
George Huff	Westbound at Vine
Park	Eastbound at Romine
Park	Westbound at Romine


Section 2. That Schedule VIII, of Section 8-3, of
Article VIII of the Urbana Local Traffic Ordinance, as amended,
be and the same is hereby further amended by deleting from that
Schedule the following intersections where drivers of vehicles
shall be required to yield before entering the intersection:

Romine	Northbound at Park
Romine	Southbound at Park

This Ordinance shall be in full force and effect from
and after its passage and publication in accordance with the terms
of Section 1-2-4 of the Illinois Municipal Code.

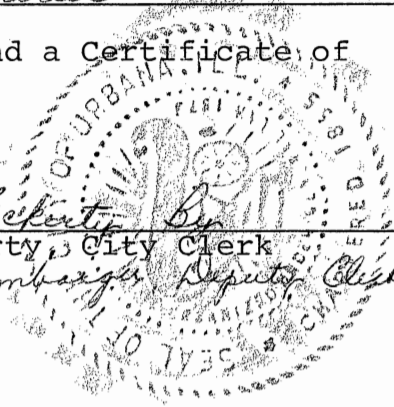
