

ORDINANCE ANNEXING CERTAIN TERRITORY

TO THE CITY OF URBANA

WHEREAS, the hereinafter described territory is situated in unincorporated territory adjacent to and contiguous to the City of Urbana, Illinois, and is part of the Philo Fire Protection District, and Notice was given to the Trustees of the said Fire Protection District, said Notice being mailed on the 23rd day of June, 1977, that this Ordinance would be voted upon at the regular meeting of this Council at 7:30 P.M., Tuesday, July 5, 1977, and the Affidavit of mailing such notices was duly recorded with the Recorder of Deeds of Champaign County, Illinois, and

WHEREAS, a written Petition signed by all of the owners of Record and all electors residing therein, of all land within such territory has been filed with the City Clerk of the City of Urbana, Illinois, requesting annexation thereof to the City of Urbana, and

WHEREAS, it has been determined that said Petition complies with all requirements of the law therefor, and

WHEREAS, the majority of the members of the Council are of the opinion that it would be for the best interests of the People of the City of Urbana, Illinois, that said territory be annexed to and made a part of the said City,

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS,

Section 1. That the following described real estate, viz:

Beginning at the Northwest corner of the East half of the Northeast Quarter of Section 28, Township 19 North, Range 9 East of the Third Principal Meridian, Champaign County, Illinois; thence S 0° 40' 37" East, 40.00 feet; for a true point of beginning; thence N 89° 36' 59" E, 587.54 feet; thence S 00° 23' 01" E, 230.00 feet; thence S 89° 36' 59" W, 20.12 feet; thence S 00° 23' 01" E, 110.00 feet; thence N 89° 36' 59" E, 32.47 feet; thence S 26° 56' 32" W, 173.99 feet; thence S 00° 23' 01" E, 95.38 feet; thence S 89° 36' 59" W, 417.00 feet; thence N 00° 40' 37" W, 72.47 feet; thence S 89° 19' 23" W, 100.00 feet to the West line of the East half of the Northeast Quarter of said Section 28, 478.00 feet, more or less, to the true place of beginning, and also all adjoining street right-of-way of Illinois Route 130 described as follows: beginning at the Northwest corner of the East half of the Northeast Quarter of said Section 28, thence S 0° 40' 37" E, 40.00 feet; thence N 89° 36' 59" E, 587.54 feet; thence N 0° 23' 01" W, 70.00 feet; thence S 89° 36' 59" W, 587.54 feet; thence S 0° 40' 37" E, 70.00 feet to the point of beginning, (part of above described right-of-way of Illinois Route 130 being reannexed), above described tracts containing 7.88 acres, more or less, all situated in Champaign County, Illinois.


