7879-1 ORDINANCE NO. XXXXXXXXXX

AN ORDINANCE AMENDING CHAPTERS 27 AND 30 OF THE URBANA CITY CODE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Section 27.12, entitled "Use of public sewers", of Chapter 27, entitled "Sewers and Drains", shall be amended by adding the following language to that section:

> No water from any source shall be pumped or discharged in any manner if such pumped or discharged water may reasonably be expected to run onto the surface of the public rightof-way. This provision shall not be effective for installation or discharges prior to the date of this enactment.

Section 2. That Section 30.8, entitled "Construction of streets, alleys, walks, and drainage systems - Requirements", of Chapter 30, entitled "Subdivision of Land", shall be amended by adding the following language to paragraph 12 of said section:

> No water from footing tiles or any other source shall be pumped or discharged if such water may reasonably be expected to run onto the surface of the public right-of-way. Where possible such water shall be connected to discharge directly into the installed underground drainage facilities."

This Ordinance shall be in full force and effect from and after its passage and publication in accordance with the terms of Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the City Council of Urbana, Illinois, at a regular meeting of said Council.
