AN ORDINANCE AMENDING THE CATV FRANCHISE ORDINANCE NO. 7273-68, AN ORDINANCE ESTABLISHING THE CONDITIONS FOR AWARDING, TO CHAMPAIGN-URBANA COMMUNICATIONS, INC., A FIFTEEN (15) YEAR NON-EXCLUSIVE FRANCHISE TO CONSTRUCT, OPERATE AND MAINTAIN A COMMUNITY ANTENNA TELEVISION SYSTEM WITHIN THE CITY OF URBANA, ILLINOIS; SETTING FORTH CONDITIONS ACCOMPANYING THE GRANTING OF SAID FRANCHISE; PROVIDING FOR CITY REGULATION AND USE OF THE COMMUNITY ANTENNA TELEVISION SYSTEM; PRESCRIBING PENALTIES FOR VIOLATION OF THE PROVISIONS HEREOF; AND PROVIDING FOR PAYMENT FOR THE PRIVILEGE OF SAID FRANCHISE.

WHEREAS, in order to optimally promote the development of cable television in the Cities of Urbana, Illinois and Champaign, Illinois, it is the desire of both Cities to enact identical ordinances which grant Champaign-Urbana Communications, Inc. the franchise to construct, maintain and operate a CATV System to both Cities. By enacting identical ordinances, both Cities seek to ensure ease of oversight by their Joint Commission on CATV; and

WHEREAS, the Champaign-Urbana Joint CATV Commission has reviewed and analyzed various Sections of Ordinance No. 7273-68, as amended, and has recommended to the Council amendments to Ordinance No. 7273-68, as amended; and

WHEREAS, the Council accepts and approves as in the best interest of the City the amendments recommended by the CATV Commission; and

WHEREAS, public hearings were conducted pursuant to and in accordance with Section 27 of Ordinance No. 7273-68, as amended, on October 11, 1978 and November 15, 1978.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

1. That Ordinance No. 7273-68, "An Ordinance Establishing The Conditions For Awarding, To Champaign-Urbana Communications, Inc., A Fifteen (15) Year Non-Exclusive Franchise To Construct, Operate And Maintain A Community Antenna Television System Within The City Of Urbana, Illinois; Setting Forth Conditions Accompanying The Granting Of Said Franchise; Providing For City Regulation And Use Of The Community Antenna Television System; Prescribing Penalties For Violation Of The Provisions Hereof; And Providing For Payment To The City For The Privilege Of Said Franchise", passed and approved by the

1817-59

Council and Mayor on February 19, 1973; and as further amended, be and is hereby amended as follows:

- (a) That subsection (18) of Section 3, entitled "Definitions", be and is hereby added immediately after subsection (17) as follows:
 - "(18) 'Monitoring' means observing a communications signal, or the absence of a signal, where the observer is neither the subscriber nor the programmer, whether the signal is observed by visual or electronic means, for any purpose, whatsoever; provided, however, 'monitoring' shall not include systemwide, non-individually addressed sweeps of the cable system for the purposes of verifying system integrity, controlling return path transmissions, or billing for pay services."
- (b) That item (i) of subsection (14) of Section 12, entitled "Services to be Provided by Grantee", be and is hereby amended to read as follows:
 - "(i) A stereo classical FM radio station imported from Chicago, presently to be WNIB."
- (c) That item (k) of subsection (14) of Section 12, entitled "Services to be Provided by Grantee" be and is hereby added immediately after item (j) as follows:
 - "(k) WPCD, Champaign, Illinois."
- (d) That items (d), (e), (f) and (g) of subsection (15) of Section 12, entitled "Services to be Provided by Grantee" be and are hereby amended to read as follows:
 - "(d) Unspecified radio station (AM or FM)."
 - "(e) Unspecified radio station (AM or FM)."
 - "(f) Unspecified radio station (AM or FM)."
 - "(g) Unspecified radio station (AM or FM)."
- 2. That all ordinances or parts thereof in conflict or inconsistent with the provisions of this ordinance be and they are hereby repealed.
