Section 1. A special use permit for the following described property is hereby granted:

Lot 8 of lot C of the S.H. Busey's Survey, Township 19 North, Range Nine East of the Third Principal Meridian situated in the City of Urbana, Champaign County, Illinois.

Commonly known as 800 West Park Street, Urbana, Illinois.

Section 2. The special use permit is subject of the following conditions and limitations:

- a. The parking lot planned for this location shall comply with all the development regulations of the R-1 district. Permanent paving shall be installed before use as a parking lot.
- b. The parking lot at this location shall be screened by a fence or hedge of sufficient density to shield the adjacent residences from direct lighting.
- c. The parking lot shall be provided with lights according to plans approved by the Director of Community Development.
- d. Fifteen foot setbacks should be provided along the two street frontages, and the visibility triangle provided at the two street intersection.
- e. The parking lots shall be designed so as to incorporate the findings and recommendations of the traffic study to be completed on this area by the Urbana transportation consultants. The plans for this and the other newly proposed parking area shall meet with the approval of the Director of Engineering.
- f. An overall drainage plan shall accompany the building permit application indicating not only the drainage design for newly proposed lots, but incorporating the total drainage design of the hospital area.
