AN ORDINANCE LEVYING A TAX
FOR STREET AND BRIDGE PURPOSES

WHEREAS, the City of Urbana, Illinois includes wholly within its corporate limits the Town of Cunningham; and

WHEREAS, Section 11-81-1 of the Illinois Municipal Code (Ill. Rev. Stats., Ch. 24, Section 11-81-1) provides that the corporate authorities of any such municipality which includes wholly within its corporate limits a township, may levy, annually, a tax for street and bridge purposes upon the value, as equalized or assessed by the Department of Local Government Affairs, of all taxable property in any such township; and

WHEREAS, street and bridge tax so authorized by this Section 11-81-1 shall be in addition to:

(1) any tax that such a municipality is now authorized to levy for street or bridge purposes, and

(2) the tax that such a municipality is now authorized to levy upon all property within the municipality, and

(3) the amount authorized to be levied for general purposes as provided by Section 8-3-1 of the Illinois Municipal Code.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That the total amount of budgeted appropriations for street and bridge purposes legally made to be collected from the tax levy of the current fiscal year of the City of Urbana, Illinois, is hereby ascertained to be Sixty-one Thousand, Two Hundred Dollars (\$61,200.00).

Section 2. That the sum of Sixty-one Thousand, Two Hundred Dollars (\$61,200.00), being the total appropriations heretofore legally made which are to be collected from the tax levy of the current fiscal year of the City of Urbana for street and bridge purposes, be and the same is hereby levied upon all of the taxable property within the Township of Cunningham, Champaign County, Illinois, subject to taxation in the current fiscal year, as such property is equalized and assessed for state and county purposes.

The specific amount as herein levied for street and bridge purposes is separately included herein by being placed in a separate column under the heading "To Be Raised by Tax Levy" which appears over the same, the total of which has been ascertained as aforesaid for the particular purpose as follows:

Section 3. That this levy totaling Sixty-one Thousand, Two Hundred Dollars (\$61,200.00) shall be and the same is in addition to:

(1) any tax that such a municipality is now authorized to levy for street or bridge purposes, and

(2) the tax that such a municipality is now authorized to levy upon all property within the municipality, and

(3) the amount authorized to be levied for general purpose as provided by Section 8-3-1 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council on the 20th day of August, 1979.
