AN ORDINANCE
AMENDING ORDINANCE NO. 7980-10, ENTITLED
"ANNUAL TAX LEVY ORDINANCE OF THE CITY OF URBANA, ILLINOIS
FOR THE YEAR BEGINNING JULY 1, 1979, AND ENDING JUNE 30, 1980"

WHEREAS, the City Council of the City of Urbana, Illinois did, on the 20th day of August, 1979, duly pass Ordinance No. 7980-10, which said Ordinance was approved by the Mayor on the 22nd day of August, 1979; and

WHEREAS, the City Council of the City of Urbana, Illinois now desires to amend such Ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL ON THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That section (2) of Ordinance No. 7980-10, entitled "Annual Tax Levy Ordinance of the City of Urbana, Illinois for the Year Beginning July 1, 1979, and Ending June 30, 1980", be and the same is hereby amended by changing the specific amounts as levied for the following various funds therein named and separately included therein by being placed in separate columns under the heading, "To Be Raised by Tax Levy", which appears over the same, the tax so levied being for the current fiscal year of the City of Urbana and for the said budgeted appropriation to be collected from said tax levy in the following respects:


