

AN ORDINANCE AUTHORIZING THE SALE OF VARIOUS  
AND MISCELLANEOUS ITEMS OF PERSONAL PROPERTY  
OWNED BY THE CITY OF URBANA, ILLINOIS

WHEREAS, the City of Urbana, Illinois, owns the items of personal property listed on the attached page which said items have been determined to be of no further use to the City of Urbana, Illinois, by the various Department Heads hitherto utilizing such items; and

WHEREAS, the City Council finds that those items in the list attached are no longer necessary or useful to, or for the best interests of the City of Urbana to retain.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That the items listed on the attached page, which said page is incorporated herein by reference, shall be offered for sale to the highest bidder at the next regular auction of items of personal property conducted by the City of Urbana.

Section 2. This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of three-fourths of the members of the City Council of the City of Urbana, Illinois, then holding office at a regular meeting of said council.

Section 3. This Ordinance shall be in full force and effect from and after its passage and recording as provided by law.

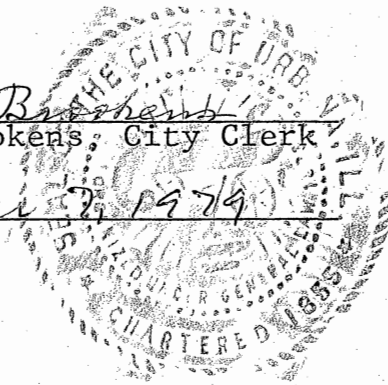
