

AN ORDINANCE
 AMENDING THE URBANA LOCAL
TRAFFIC ORDINANCE, AS AMENDED

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

That Schedule X, entitled "Parking Prohibited During Certain Hours on Certain Days," of Section 14-4, entitled "Parking Prohibited During Certain Hours on Certain Streets," of Article XIV, entitled "Stopping, Standing or Parking Restricted on Certain Streets," of the Urbana Local Traffic Ordinance, as amended, be and the same is hereby further amended by adding to that Schedule X the following portions of streets where parking shall be prohibited between the hours of 3:00 A.M. and 6:00 A.M. on each and every day:

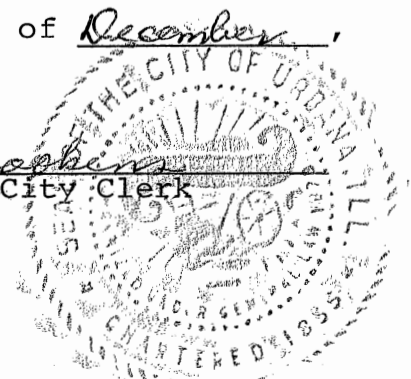
