

ORDINANCE ANNEXING CERTAIN TERRITORY
TO THE CITY OF URBANA

WHEREAS, a Resolution describing the real property set forth below was duly passed by the Urbana City Council on December 3, 1979, in which said Resolution the Urbana City Council determined to contemplate the question of whether the property therein described should be annexed to the City of Urbana, Illinois, and directed the City Clerk to publish Notice that the annexation of the properties therein described would be considered by the Urbana City Council at its regular meeting on December 17, 1979, and

WHEREAS, the City Council of Urbana, Illinois duly published such Notice on December 6, 1979, in The News-Gazette, a newspaper having general circulation in the City of Urbana, Illinois, and the area proposed to be annexed, a Certificate of Publication therefor being on file with the City Clerk's Office, and

WHEREAS, the hereinafter described territory is situated in unincorporated territory adjacent to and contiguous to the City of Urbana, Illinois, and is part of the Eastern-Prairie Fire Protection District, and Notice was given to the Trustees of the said Fire Protection District, said Notices being mailed on December 6, 1979, that this Ordinance would be voted upon at the regular meeting of this Council at 7:30 P.M., Monday, December 17, 1979, and the Affidavit of mailing such Notices was duly recorded with the Recorder of Deeds of Champaign County, Illinois on the 10th day of December, 1979, and

WHEREAS, the majority of the Members of the Council are of the opinion that it would be for the best interests of the People of the City of Urbana, Illinois, that said territory be annexed to and made a part of the said City,

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:

Section 1. That the Urbana City Council finds and determines that the property described below is surrounded by property previously annexed to the City of Urbana, Illinois, within the meaning of Section 7-1-13 of the Illinois Municipal Code.

Section 2. That the following described real estate, viz:

Commencing at the Southwest corner of Section 5, Township 19 North, Range 9 East of the Third Principal Meridian, thence N 00° 02' 46" E, 1758.66'; thence S 89° 57' 14" E, 48.54' for a true point of beginning; thence S 89° 57' 14" E, 178.47'; thence S 00° 20' 25" W, 249.94'; thence N 89° 48' 38" W, 40.98'; thence S 00° 00' 25" W, 175.00';

thence N 89° 38' 04" W, 150.00', to the East Right-of-Way line of Lincoln Avenue; thence Northerly along said Right-of-Way line to the point of beginning; said tract containing 1.90 acres, more or less,

commonly known as 2002, 2008 and 2012 North Lincoln Avenue, Urbana, Illinois,

be and the same is hereby annexed to the City of Urbana, Illinois.

Section 3. That the City Clerk be authorized and directed to file for record a certified copy of this Ordinance together with an accurate map of the territory hereinabove described in the Office of the Recorder of Deeds for Champaign County, Illinois.

Section 4. This Ordinance shall be in full force and effect from after its passage and recording as provided by law.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council on the 17th day of December, A.D. 1979.
