

AN ORDINANCE
TO MAKE BUDGET APPROPRIATIONS FOR
CITY OF URBANA
SPECIAL SERVICE AREA NUMBER TWO

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1: Findings. The City of Urbana Special Service Area Number Two has been created by an Ordinance, entitled "An Ordinance Establishing City of Urbana Special Service Area Number Two", adopted September 7, 1976, approved September 8, 1976, and effective as of September 8, 1976, and no petition has been filed opposing the creation of the special service area pursuant to Chapter 120, Illinois Revised Statutes, Section 1309. Said Special Service Area Number Two consists of the territory described in the Ordinance aforesaid. The City of Urbana is now authorized to levy taxes for special services in said Special Service Area Number Two.

Section 2: That the following sums have heretofore been authorized by the City Council of the City of Urbana to pay part of the costs of construction of Local Improvement Project 186-CS which includes all necessary city expenses of Special Service Area Number Two, such authorizations being for services and improvements for Special Service Area Number Two which have heretofore been authorized to be paid from the Motor Fuel Tax Fund by various resolutions of the City Council authorizing the same, and such authorizations being made to pay such part of the cost of construction of Local Improvement Project 186-CS for the following objects and purposes:

Section 3: That the following sums are now hereby budgeted for the purpose of partially reimbursing the Motor Fuel Tax Fund for


the payment of some of the necessary expenses of Special Service Area Number Two for the fiscal periods beginning July 1, 1980 and ending June 30, 1990:
