BE IT ORDAINED by the City Council of the City of Urbana,

Champaign County, Illinois, as follows:

Section 1: A local improvement shall be constructed in the City of

Urbana consisting of:

Approximately 18,195 lineal feet of sanitary sewer pipe comprised of ten inch diameter, eight inch diameter, and six inch diameter pipe; the construction of approximately forty-eight 48-inch diameter manholes; installation of one duplex factory lift station-wet well and auxiliary power supply; replacement of the portland cement concrete pavement; replacement of the brick pavement; replacement of portland cement concrete curb and gutter; replacement of portland cement concrete sidewalks; placement and removal of temporary fence; construction of a four inch diameter force main; construction of conflict manholes, and other incidental work to make the system functional in the area bounded generally by Florida, Race, Washington, and Orchard Streets, as shown in Exhibit "A" attached hereto and incorporated herein by reference,

and as shown on the plans dated June 4, 1980, approved by the Board of Local Improvements.

That it is necessary to acquire permanent and temporary easements on certain property as described in Exhibit "B" attached hereto and incorporated herein by reference, which said easements are necessary, required, and needed for the purpose of placing and maintaining sanitary sewers to serve portions of the project area north of Michigan Avenue and shall be obtained by written agreements to be recorded with the Recorder of Deeds of Champaign County, Illinois.

Section 2: City Datum for the purpose of this improvement is fixed and established as the official datum of the United States Geological Survey.

All materials of every kind and character to be used in the construction of this improvement shall be first class quality, suitable for the purpose for which they are to be used, and subject to the inspection and approval of the Board of Local Improvements of the City of Urbana, Champaign County, Illinois.

All work shall be constructed in a workmanlike manner under the superintendence of the Board of Local Improvements of the City of Urbana, Illinois.

All construction methods and materials used in construction of the improvement herein provided for shall conform with the requirements of the "Standard Specifications for Water and Sewer Main Construction in Illinois", Third Edition, adopted by the Illinois Society of Professional Engineers and the Association of General Contractors in Illinois, in September, 1978, and the "Standard Specifications for Road and Bridge Construction" prepared by the Department of Transportation, State of Illinois, and adopted by said department on October 1, 1979, and the special provisions prepared by Berns, Clancy and Associates, Engineers, Urbana, Illinois, copies of which are on file with the City Clerk of the City of Urbana.

The quanitities and types of materials to be used are as set forth in the estimate of cost attached hereto and incorporated herein by reference.

Section 3: The recommendation of the Board of Local Improvements, the estimate of cost thereof and the plans, being the same plans as referred to in Section 1, all hereto attached and incorporated herein by reference be and the same hereby are approved.

Section 4: That said improvements shall be made and the cost thereof is estimated to be \$1,606,646.00 of which an amount estimated to be \$347,212.00 shall be paid for by special assessment in accordance with Article 9, Division 2 of Chapter 24 of the Illinois Municipal Code, and the remainder of the cost shall be paid by the City of Urbana.

Section 5: The aggregate amount herein ordered to be assessed and each individual assessment shall be divided into ten (10) installments which shall bear interest at the rate of seven percent (7%) per annum until paid all in the manner and in accordance with the provisions of the aforesaid Article 9, Division 2 of Chapter 24 of the Illinois Municipal Code.

Section 6: For the purpose of anticipating the collection of the second and succeeding installments of said assessment for said improvement, bonds shall be issued payable out of said installments, bearing interest at the rate of seven percent (7%) per annum, payable annually, and signed by the Mayor of the City of Urbana and attested by the City Clerk, under the corporate seal of the City. The bonds shall be issued in accordance with and shall in all respects conform to the provisions of Article 9, Division 2 of Chapter 24 of the Illinois Municipal Code, as amended.

Section 7: Jeffrey T. Markland, Mayor of the City of Urbana, Illinois, is designated as the person to file a petition in the Circuit Court of Champaign County, Illinois, as provided by law in the name of the City of Urbana, Illinois, praying that steps may be taken to ascertain the just compensation to be made for private property taken or damaged or permanent and temporary easements to be acquired for the said improvement and to ascertain what property


