AN ORDINANCE
AMENDING THE ZONING ORDINANCE
OF THE CITY OF URBANA, ILLINOIS

WHEREAS, after due notice, a public hearing was held by the Urbana Plan Commission on the 19th day of March, 1981, in Plan Case #1111-T-81; and

WHEREAS, the Urbana Plan Commission has recommended approval of the following change to the text of the Zoning Ordinance of the City of Urbana, Illinois.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That paragraph (5) of subsection B, entitled "Proceedings of the Plan Commission", of Section XI-2, entitled "Plan Commission", of the Zoning Ordinance of the City of Urbana, Illinois, which reads as follows:

"5. All testimony by any witness shall be given under oath. The Chairman, or in his/her absence, the Acting Chairman, may administer oaths.",

is hereby repealed on the effective date of this Ordinance and subsections B(6) through (10) shall be renumbered accordingly.

Section 2. This Ordinance shall be in full force and effect from and after its passage and publication in accordance with the terms of Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council on the 20th day of April, 1981.
