That subsection (a) of Section 11-19, entitled "Open burning", of the Code of Ordinances, City of Urbana, Illinois, be and the same is hereby amended by adding a new (5) to the existing exceptions when open burning is permitted in the City of Urbana:

- (5) That the burning of leaves, during daylight hours of the months of October, November, December and April shall be permitted under the following terms and conditions:
 - (i) The leaves shall be burned on the resident's property and not on public right-of-way.
 - (ii) The burning of such leaves shall be at least fifteen (15) feet from any structure and five (5) feet from any property line.
 - (iii) The burning of such leaves shall be under the supervision of a person at least eighteen (18) years of age.

This Ordinance shall be in full force and effect from and after passage and publication in accordance with the terms of Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois at a regular meeting of said Council on the 2ml day of February 1981.
