

ORDINANCE ANNEXING CERTAIN TERRITORY
TO THE CITY OF URBANA

WHEREAS, the hereinafter described territory is situated in unincorporated territory adjacent to and contiguous to the City of Urbana, Illinois, and is part of the Carroll Fire Protection District, and Notice was given to the Trustees of the said Fire Protection District, said Notices being mailed on February 2, 1981, that this Ordinance would be voted upon at the regular meeting of this Council at 7:30 P.M., Monday, February 16, 1981, and the Affidavit of mailing such Notices was duly recorded with the Recorder of Deeds of Champaign County, Illinois on the 5th day of February, 1981, and

WHEREAS, a written Petition signed by all of the owners of Record (there being no electors residing therein), of all land within such territory, has been filed with the City Clerk of the City of Urbana, Illinois, requesting annexation thereof to the City of Urbana, and

WHEREAS, it has been determined that said Petition complies with all requirements of the law therefor, and

WHEREAS, the majority of the Members of the Council are of the opinion that it would be for the best interests of the People of the City of Urbana, Illinois, that said territory be annexed to and made a part of the said City,

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:

Section 1. That the following described real estate, viz:

From the point of intersection of a line 30.00 feet South of and parallel with the North Line of Section 9, Township 19 North, Range 9 East of the 3rd Principal Meridian and the Easterly right-of-way line of U.S. Route 45 as monumented and occupied in May 1975 proceed thence North 90° 00'00" East 294.45 feet along said Line 30.00 feet South of the parallel with the North Line of said Section 9 to a point which lies 6.78 feet East of the West line of Lot 2 of a Subdivision of the West half of the Northwest Quarter of said Section 9; Thence South 01° 20'16" East 22.77 feet to a point on the Southerly right-of-way line of Perkins Road, said point being the true point of beginning; Thence South 01° 20'16" East 110.26 feet; Thence North 89° 55'53" East 321.30 feet to the East line of said Lot 2; Thence South 00° 28'24" East 496.10 feet along the East line of said Lot 2 to the South line of said Lot 2; Thence South 89° 41'07" West 330 feet along the South line of said Lot 2 to the Southwest corner of said Lot 2; Thence Northerly along the West line of said Lot 2 to the Southerly right-of-way line of Perkins Road; Thence North 89° 27'43" East along the Southerly right-of-way line of Perkins Road to the true point of beginning, encompassing 3.78 acres, more or less, in Champaign County, Illinois.

commonly known as 1504 North Cunningham, be and the same is hereby annexed to the City of Urbana, Illinois. The above-described parcel, prior to annexation, has the permanent index number 30-21-08-103-014, and following annexation the said parcel will bear the permanent index number 91-21-08-103-014.

Section 2. That the City Clerk be authorized and directed to file for record a certified copy of this Ordinance together with an accurate map of the territory hereinabove described in the Office of the Recorder of Deeds for Champaign County, Illinois.

Section 3. This Ordinance shall be in full force and effect from after its passage and recording as provided by law.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council on the 16th day of March, A.D. 1981.

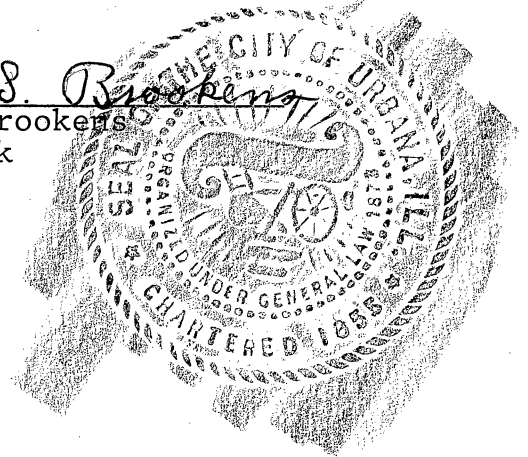
